FROM OUR MANAGER: Memorial Day is coming soon and we will be in full swing for the 2011 season. I am looking forward to seeing you all again.

There are a few items that I wanted to make sure that you were notified about.

At the Board Meeting on May 15, 2011 the Board of Directors voted to charge for guests at the gate. The fee per car will be \$15.00 per day. I want to remind everyone to make sure you have your gate tags when you are coming into the gate because any car that comes to the gate without a gate tag – member or guest – will be charged the \$15.00.

There were a few rule changes that also were approved at the last Board Meeting. Air conditioners are not permitted to be operated when trailer unit is unoccupied for more than 48 hours. Exterior lights must be turned off during the daylight hours. This rule was put in place to help conserve on our utility bill. Please think of these items before you leave the park to go home. The more that we all pay attention to utilities, the lower our bills will be. A rule to ban electric cars until further investigation of electrical consumption was also added to the Rules and Policies.

The weather here at Slippery Rock Campground has been very wet. Many of you are experiencing an excess amount of water on your lots. We are trying to do everything that we can to help with this situation but we need some dry weather to work on some items that can help make a difference. We also are having trouble keeping up with the grass cutting as many of you are too. We all need the sun to come out and stay out until we can get everything in order. Thank you for your patience.

RULE 8 – Vehicle Requirements (including Golf Carts, Motorcycles and Scooters)

1. All vehicles (motorized or person powered) must obey the 12 (twelve) mile per hour speed limit or posted speed limit.
2. Any golf cart being operated in the park at or after dusk must have the following:
 - a. Headlights turned on. These headlights must be permanently affixed and must be factory equipment or its equivalent.
 - b. At least 1 (one) rear reflector or light.
3. All golf carts operated in the campground shall be commercially manufactured or its equivalent, electric powered and registered at the Office with any required forms, signed and placed on file at the Office. Owners of any golf cart(s) must purchase a golf cart registration sticker and pay an additional fee/surcharge as determined by the Board of Directors. Additionally, all golf carts on the premises of SRCA must have a current golf cart registration sticker by Memorial Day of the current calendar year. The owner's lot number must be displayed on the front and rear of the cart in lettering at least 3 (three) inches tall. Reflective lettering is required.
4. All golf carts must be driven to the Office or (designated) location for visual verification of placement of golf cart sticker. The golf cart registration sticker must be placed on the driver's side of windshield (if equipped) or driver's side of cart in a visible location.

OPERATOR / PASSENGERS:

1. All licensed drivers operating vehicles in SRCA must obey all the "Rules of the Road" of Pennsylvania including but not limited to Stop Signs, Rights of Way and Speed Limits.
2. Motorcycles may be operated to and from the front entrance gate of SRCA to the member's site or to the site the visitor is coming to see.
3. Only licensed state motor vehicle drivers or INDIVIDUALS 14 (fourteen) years or older (with proof of age and registered at the Office) shall be permitted to operate golf carts.
4. Persons under the age of 18 (eighteen) years old may operate a golf cart up to the 11:15 PM curfew (refer to Rule 9-B).
5. No vehicle shall be operated with a leashed pet, which is walking or running along the side of that vehicle.
6. There shall be absolutely NO standing in or on the golf cart while in operation.

Issues of Security

Another Season has arrived. Lawns are being mowed, trees are being trimmed, and gravel's being laid... it's all looking pretty good. It was a tough winter at the campground. Knee deep snow, endless doors popping open, ground shift and flooding. Security did its best to keep an eye out for your property. Security is not here to police you. We are here to protect and watch out for the safety of you, you're children, and your property. We know that everybody is here to have a good time and relax; however, we have to enforce rules.

There are times when our CB's cannot respond or hear calls being made. There are many dead spots in the Campground. If there is a major issue that needs addressed and you are not getting through on a CB, please call the office number, as we check messages every hour. If you call on the CB from the back gate or front gate, please say where you are calling from so Security knows where you are.

Parents, please help us watch out for your kids! Make sure they are wearing some kind of reflective gear at night. The roads are dark and one sharp turn can be devastating if they are walking alongside the road.

Teenagers, WATCH YOUR SPEED, because Security will be watching it also! We have three-year-olds and five-year-olds that chase their balls out onto the street and suicidal bunny rabbits that will wait until you turn the bend before they run out in front of you. GRRRRR...
