HDTV SETTING TO SAVE ELECTRICITY: A few basic tweaks on your

HDTV's picture settings can save you up to \$50 a year on your power bill, and you'll get a better-looking image in the bargain, according to the A/V experts at THX.

High-Def Digest spotted this new survey from THX, which took more than a dozen plasma and LCD HDTVs and compared their pre- and post-calibration energy consumption.

What the researchers at THX found was interesting: namely, that a "properly" calibrated HDTV uses anywhere from 15 to 50 percent less energy than a TV that's still using the factory picture settings—and typically, that means the "Vivid" or "Dynamic" picture presets, which look great on a brightly lit showroom floor but garish in a dark living room.

Assuming four hours of daily use at 11.36 cents per kilowatt hour, switching your HDTV from the Vivid or Dynamic picture settings to "Standard," "Cinema," or "Custom" along with properly tweaked brightness and contrast settings, could save you up to \$40-\$50 a year—not a king's ransom, exactly, but hey, it's something. (Apparently, plasma HDTVs manufactured before 2008 will see the most savings, followed by LCD sets. Also, the bigger the screen, the bigger the savings, according to the THX report).

So, what's involved in getting your HDTV calibrated? Well, you could spend hundreds of dollars on a professional, in-home calibration, but you can also get solid results from an inexpensive HDTV calibration disc. My favorite: Joe Kane's "Digital Video Essentials," available online for \$25 (DVD) and \$29 (Blu-ray). Just follow the instructions, which step you through the basic picture settings and test patterns. Once you're done, don't be surprised if your picture "pops" a lot more than it did before.

Don't want to bother with a calibration disc? At least check your picture settings and make sure you're not on the "Vivid" or "Dynamic" presets. Trust me, your picture will look the better for it, and a few extra bucks in your pocket never hurts.

FROM OUR MANAGER DIANE: "LOOKING FOR VOLUNTEERS"

I am trying to see if we have enough volunteers to work at the pool for the upcoming season. If possible, I thought that we could run it like we do our volunteers at the gate – 2 hour shifts the same day each week. You would be a Volunteer "Pool Attendant". The following is a brief job description:

To enforce the "Pool Rules" as follows:

- A. Children under the age of 12 years old must be accompanied by an adult.
- B. No Running or Horseplay.
- C. No Diving or Cannon balling.
- D. Inflatable devices will be permitted at the staff's discretion.
- E. Bathing suits only (No cutoffs) required in pool area except those adults watching children under 12.
- F. No food, gum, or glass containers.
- G. No pets.
- H. Suntan lotion only NO OIL.
- I. No Eating and No Smoking in fenced area.
- J. Adult Swim will be held at 15 minute intervals every two hours.
- K. Pool hours are 12:00 8:00 PM.

Pool personnel have the authority to enforce the above rules and shall eject anyone for non-compliance of these rules or refer to the proper authority. If the campground members or their guests give any pool attendant a difficult time about the rules, procedures, etc., you are to contact Security, Diane or Maintenance for assistance.

Inclement weather procedure: If there is a thunderstorm approaching, Attendants must be vigilant. At the first sound of thunder, attendants must blow their whistle and ask everyone to get out of the water and the pool area. Members are allowed to leave belongings in the pool area, but must leave the area. All gates should be locked (Attendants must leave the pool area as well). The pool may be reopened 30 minutes after the last thunder.

In case of any emergency: Please contact Security immediately using the CB radio in the Pool Attendant's Shack. Please clear the area that the emergency is taking place in. Security will contact the medical team in the campground. Once the medical team and security arrive at the scene, they will take over. In the event of minor injuries incurred at the pool – there is a first aid kit in the shack. Unless you have First-Aid or First Response certification, you are unable to administer any of the ointments to the members or their guests. However, you are allowed to give them the medication. If ever you feel incapable of dealing with the situation, please contact Security, Diane or Maintenance.

Cleaning/General Maintenance: Sweep Deck (any foreign materials on the deck - grass, leaves, etc.). Hose deck as needed. Test Pool using testing kit. Organize chairs at closing and close and store umbrellas. Chairs must be placed along the fence so that general maintenance and cleaning is more efficient the next day. Clean filters and any other maintenance requested by staff.

If this sounds like something that you would be interested in, please contact me at the Office this winter.

Maintenance Report: The water treatment building is almost complete. The walls and ceiling have been insulated with spray foam insulation. The existing structure over the storage tanks has been removed allowing the staff to check our water without crawling around on their knees. The concrete floor has been poured, expanding the filter area. With a little more straightening up of the plumbing, electric and water testing area, the project could be completed by the end of this year.

We are still updating and replacing sewage lines throughout the campground that have been crushed or clogged with roots. Please be patient with the maintenance staff when they come onto your lot. This is a temporary inconvenience for a permanent fix.

Regarding fallen tree branches and branches cut by you: if you can please cut them in to small pieces and burn them in your fire ring, this will allow our staff time to work on other projects throughout the year instead of cleaning up your tree trimmings. If you have an independent contractor come into the campground and cut down a tree, he is responsible to remove all branches from the campground. Our maintenance staff will not be permitted to clean up after another outside vendor.
